Church Health - This department exists to provide relevant and high-quality resources, services, and partnerships that will strengthen healthy churches, revitalize declining churches, and resurrect dead churches. We have continued to work with Natural Church Development to evaluate the health of existing churches and aid them in strengthening their weakest areas. Several churches have gone through at least one phase of the NCD process or have sought consultation in evaluating their options for the future, though the pandemic has limited our opportunities to connect with churches. In addition, we continue to offer print and electronic resources to all our churches.
